### Dean's Decree No. 9/2025 on banning the use of electronic aids in examinations at the 3rd Medical Faculty of Charles University

#### Article 1

##### Subject of modification

1. This measure of the Dean sets out the rules for the use of electronic aids in the course of study checks.

#### Article 2

##### Study control

1. For the purposes of this measure, the control of studies means in particular a colloquium, a credit, a graded credit and an examination.

#### Article 3

##### Permitted aids to study control

1. In the course of the study control, the student is obliged to work only with the aids permitted for the study control of the given subject.
2. **The student is expressly obliged to refrain from using any electronic devices such as mobile phones, tablets, laptops and computers, smart watches and fitness bracelets, headphones, smart glasses with camera, etc. during the study control.**
3. If there is a reasonable suspicion of a breach of an obligation under the preceding paragraph, the examiner shall be entitled to make a verbal warning in order to prevent possible fraudulent conduct or to check the obligations under the preceding paragraph. The challenged student shall comply with the warning.
4. Where it is reasonable or practical to do so, the studies can be controlled using electronic aids. This applies in particular to examinations of studies conducted at a distance or partially at a distance by means of information and communication technologies (see Article 8(11) of the UK Study and Examination Regulations) and examinations by means of technological aids designated by the examiner (e.g. faculty tablets). The use of electronic aids in the control of studies according to the previous sentence may be resorted to only if it is possible to verify the identity of the student and to ensure compliance with the rules laid down for this control of the study of the subject.

5. If it is necessary for the purpose of supporting or monitoring the student's health, the examiner or other faculty employee responsible for the course of the study control may allow the student to use a specific electronic device (e.g. glucometer, etc.). The consent according to the previous sentence must be requested before the start of the study control and the examiner is obliged to comply with it only if the applicant has a doctor's certificate or has a record of this fact in the study information system.
6. Violation of the obligations under paragraph 2 or paragraph 3 of this Article will lead to the termination of the study control in question with a failing grade within the meaning of Article 8(5) and (13) of the Charles University Study and Examination Regulations.

#### **Article 4**

##### **Disciplinary proceedings**

1. Violation of the above rules on the use of electronics during the study control will be assessed as a disciplinary offence within the meaning of Article 2, paragraph 1 of the Disciplinary Regulations for Students of Charles University.
2. In the event that a student is caught using illegal aids, this action will be referred to disciplinary proceedings in accordance with the Disciplinary Regulations for Students of the 3rd Faculty of Medicine and the Disciplinary Regulations for Students of Charles University.
3. The examiner or the person responsible for the course of study control is obliged to notify the relevant persons in case of a violation of the rules under this measure in order to initiate disciplinary proceedings.

#### **Article 5**

##### **Final provisions**
